| Nonaffiliates   | Companies not related by common ownership or control. They can be financial and nonfinancial companies.<br>*MANHATTAN FINANCIAL GROUP, INC. does not share with non-<br>affiliates so they can market you. |
| Joint Marketing | A formal agreement between nonaffiliated financial companies that<br>together market financial products or services to you.<br>*MANHATTAN FINANCIAL GROUP, INC. doesn't jointly market.                    |
